HERKIMER COLLEGE TO HOLD SUNY COBLESKILL COURSES AT HERKIMER CAMPUS

Dr. Lynn Kattato and Nicholas Laino will be teaching the first two courses offered as part of SUNY Cobleskill's Bachelor of Business (BBA) degree completion program at Herkimer College. Both have extensive higher education teaching experience and bring a wealth of real world expertise to the classroom. The first cohort of students will be starting the program on January 22, 2019.

Dr. Kattato holds an Ed.D. in Executive Leadership and has a wealth of knowledge and experience in human resources and management. She is active in a number of professional and civic organizations. Dr. Kattato has taught numerous business management, human resources and economics courses at several area colleges. She will be instructing BADM 320 Ethics and Management from January 22 to March 14, 2019.

Laino is Senior Vice President for Administration and Finance at Herkimer College. He has a broad background in higher education administration, as well as transportation, banking, business and public management. Laino has taught courses at six colleges including business management, finance, international business, and organizational behavior. He will be teaching BADM 305 International Business from March 20 to May 10, 2019.

Classes will be held on the Herkimer campus on Tuesday and Thursday evenings in eight-week blocks. The BBA (Bachelor of Business Administration) at Herkimer is designed for traditional students and working adult learners. SUNY Cobleskill's upper-level major field courses are taught on the Herkimer College campus, with additional courses offered online. FROM THE HERKIMER COUNTY BUDGET OFFICER:

The 2019 Budget has been complete and was adopted at the December 12th
Legislative meeting. This budget includes appropriations of \$102,514,241,
department revenues of \$43,208,278, Sales Tax revenues of \$31,232,706, and
appropriated highway fund balance and reserves of \$683,050, making the 2019 tax
levy \$26,707,157. There was NO increase to the County Tax Levy for 2019. The tax rate per
\$1.00 of full value for the County homeowner, on average, will be \$5.50, down from \$5.61 in 2018,
depending on individual town and village equalization rates. The average savings on a home
valued at \$80,000 would be \$8.80.

The 2019 budget was challenged by increasing health insurance costs posing a negative impact of approximately \$373,863. Fuel and oil costs drove the highway budget contribution up \$157,995, and College Chargebacks (the amount paid for Herkimer County students attending other

institutions) increased approximately \$219,000. The County's sponsor contribution to Herkimer College was also increased by \$100,000. The increases in minimum wage, proposed legislation for Indigent Defense, increased program costs and State mandated program costs were also major drivers this year.

This year's budget did have some positive changes. Sales Tax revenues were up \$700,000, Interest and Earnings \$225,000 and Safety Net, which is traditionally one of the County's larger mandated programs, is down \$177,500. The biggest expense in the County's budget, Medicaid, is down \$26,497, coming in at \$13,189,503. All of these factors along with conservative budgeting by our departments, allowed the Legislature to keep the tax levy flat.



Through the combined efforts of the Ways & Means Committee, the full Legislature, County Administrator, Budget office and Department Heads, the 2019 Budget developed into a solid, fiscally smart financial plan. Thank you to all involved for your cooperation and effort in developing the 2019 Budget.

DID YOU KNOW???

As winter driving has now arrived, are you prepared for the inevitable slippery roads? Do you know what the difference between winter snow tires, all-weather tires, and all-season tires is? Are you aware of the differences in these tires?

An interesting article from Consumer Reports helps educate us about what tires we should use in winter. According to a number of studies and surveys, including Consumer Reports' own tests, if you live in an area where snow is a constant throughout winter, having dedicated winter/snow tires can improve your safety.

More than half of Canadian drivers install winter/snow tires on their cars, and they see a real benefit. There are fewer winter-related accidents, injuries, and deaths when cars are required to be fitted with winter/snow tires, a Quebec-based study found. And the most recent survey report from the Tire and Rubber Association of Canada suggests that two-thirds of Canadian drivers are using winter/snow tires (required in some provinces, including Quebec). Visitors to Quebec are not required to have snow tires.

In the U.S., the use of winter/snow tires is much lower among snow-belt drivers. Just two in five American motorists use winter/snow tires, according to a new survey commissioned by Michelin. The Michelin survey, which focused on the U.S., also found:

- 67 percent of respondents thought they didn't need winter tires because they had all-season tires. Consumer Reports' testing clearly shows that most winter/snow tires have better snow traction than the average all-season tires.
- 53 percent thought winter/snow tires weren't needed if they had an all-wheel-drive vehicle. But Consumer Reports subscribers consider winter/snow tires to be beneficial whether they have a two-wheel-drive or an all-wheel-drive car or SUV.
- Michelin found that three out of four drivers are nervous about driving in snow, with younger drivers more concerned than older drivers.
- The survey showed that a vast majority of drivers avoid, limit, or change plans because they don't want to drive in wintry weather. Drivers are worried about the "other guy" on the road, losing control, or getting stuck. Ultimately, staying off the road is the best way to improve safety in foul weather. Most drivers using winter/snow tires are more confident and less concerned about other drivers and the loss of traction.

However, all-weather tires—a variation of all-season tires designed to excel in tough winter conditions—can be a convenient option if you want to avoid switching to winter/snow tires in the fall and replacing them in the spring. Consumer Reports' snow-traction testing of 64 car tire models found that the best all-weather tires rival traditional all-season tires in mild weather and can provide traction in severe snow and ice conditions.

All-weather tires don't quite match winter/snow tires for maximum snow traction and ice braking, but they do have an advantage in dry braking, wet braking, handling, and tread life. They can be a year-round convenience and ultimately reduce operating costs, making them an appealing choice for drivers who face winter weather but don't need to tackle the most severe conditions.



Career Connections, a division of Arc Herkimer, and Herkimer County Community College earned a national job placement award for the Project SEARCH program. The award, presented at the annual Project SEARCH Conference in Savannah, GA honored the organizations for their collaboration to secure 100 percent placement for the first class of interns for jobs in the community earning at least minimum wage. The program is in its third year of collaboration between the nonprofit and the college.

Project SEARCH is a 40-week intern program for young adults with disabilities, ages 18 to 34, with a sole objective and intensive focus on achieving competitive employment and maximum independence for each participant. Interns, supported by Career Connections and college staff, participate in daily classroom instruction and gain hands-on work experience by rotating among three unique, unpaid internships at various sites at Herkimer College throughout the academic year.

Nature Trail Upgrades Include New Picnic Areas, Signage and Wildflowers



With a \$4,500 grant from Herkimer County HealthNet and \$4,500 in matching funds from the Herkimer County College Foundation, the Nature Trail at Herkimer College has three new picnic table

areas, as well as new signage placed at various entrance points. Additional 'trail head' signs are planned, as well as directional signs pointing trail users to various sections of the trail system.

Assistant Director of Facilities Tom Stock said, "At the pond/bridge location, two picnic tables were placed, and these will make a nice location for trail users to sit and take in the quiet location. Not far from those tables, another table is located at a wildflower bed. The bed was seeded in the fall in hopes that the 10 varieties of wild flowers in the seed mix will offer a nice addition to the area."

The nature trail, located just beyond Wehrum Stadium, is used for instructional purposes by the College and local schools. Community members also enjoy walking, hiking, running, nature watching, cross country skiing, snow shoeing, bicycling, photography, bird watching, and more.

In their commitment to improve community health, Herkimer County HealthNet partners with organizations to help improve the health and well-being of our area. "We are grateful to Herkimer County HealthNet and the Foundation for their generous investment and support of this wonderful community resource.
