LOCAL LAW No. _ 1 _ - 1975

A LOCAL LAW INCREASING THE SALARIES OF SOME COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

- Section 1. The base annual salary of the Clerk of the Legislature shall be the sum of Ten Thousand Six Hundred Ten Dollars (\$10,610.).
- Section 2. The base annual salary of the Commissioner of Jurors shall be the sum of Three Thousand One Hundred Dollars (\$3,100.).
- Section 3. The base annual salary of the County Auditor shall be the sum of Ten Thousand Dollars (\$10,000.).
- Section 4. The base annual salary of the Commissioner of County Lands shall be the sum of Two Thousand Seven Hundred Fifty Dollars (\$2,750.).
- Section 5. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of Ten Thousand Five Hundred Dollars (\$10,500.).
- Section 6. The base annual salary of the County Attorney shall be the sum of Thirteen Thousand Five Hundred Dollars (\$13,500.).
- Section 7. The base annual salary of the Civil Service Commissioners shall be the sum of One Thousand One Hundred Dollars (\$1,100.).
- Section 8. The base annual salary of the Commissioners of Elections shall be the sum of Five Thousand Seven Hundred Thirty-seven Dollars (\$5,737.).
- Section 9. The base annual salary of the Commissioner of Social Services shall be the sum of Seventeen Thousand Seven Hundred Fifty Dollars (\$17,750.).
- Section 10. The base annual salary of the Director of Veterans' Service Agency shall be the sum of Seven Thousand Seven Hundred Seventy-six Dollars (\$7,776.).
- Section 11. The salary schedule for the year 1975 shall include the annual increments and longevity increments for the officers and employees listed in Section 1 thru 10, and shall take effect January 1, 1975.
 - Section 12. This Local Law shall take effect 45 days after its adoption.

LOCAL LAW No. 2 OF 1975

A LOCAL LAW INCREASING THE NUMBER OF COUNTY CORONERS AND ESTABLISHING FOUR CORONER DISTRICTS IN THE COUNTY OF HERKIMER

BE IT ENACTED by the County Legislature of the County of Herkimer, as follows:

FIRST: That pursuant to Section 400, subdivision 3, of the County Law of the State of New York, the number of county coroners for the County of Herkimer is hereby increased to four.

SECOND:That the County of Herkimer hereby establishes four coroner districts constituted as follows:

District No. 1 - Town of Webb

District No. 2 - Towns of Ohio, Russia, Newport, Fairfield, Salisbury, Manheim, and Norway.

District No. 3 - Towns of Schuyler, Herkimer, Little Falls, Danube, Stark and Warren and the City of Little Falls.

District No. 4 - Towns of Frankfort, German Flatts,
Columbia, Litchfield and Winfield.

THIRD: That there shall be a resident coroner in each of the four districts so established, but that each coroner shall have jurisdiction throughout the County of Herkimer.

FOURTH: The term of office of each such coroner shall be three years, as set forth in Section 400, subdivision 1, of the County Law of the State of New York; that each additional position shall become effective upon completion of the requirements for a permissive referendum as provided in the Municipal Home Rule Law of the State of New York.

 $\begin{tabular}{ll} FIFTH: & The salary of each position shall be at a per diem basis at a rate \\ & to be fixed by resolution of the Herkimer County Legislature. \\ \end{tabular}$

SIXTH: This act shall take effect upon completion of the requirement for a permissive referendum as provided in the Municipal Home Rule Law of the State of New York.

LOCAL LAW No. 3 OF 1974

A LOCAL LAW PROVIDING FOR AN INCREMENT SCHEDULE FOR THE FIRST FOUR YEARS OF EMPLOYMENT OF SOME COUNTY OFFICERS AND EMPLOYEES

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. The increment schedule for the County of Herkimer is hereby amended, as of January 1, 1974, so that an annual increment of \$100. for each of the first four years of employment shall apply to the following positions: County Attorney, Assistant County Attorney, Welfare Attorneys (2) and Commissioners of Election (2).

Section 2. The salary schedule for the year 1974 is hereby amended so as to provide for the said longevity increments for the officers and employees listed in Section 1 hereof.

Section 3. This Local Law shall take effect 45 days after its adoption.
