A LOCAL LAW AUTHORIZING PAYMENT OF EXPENSES OF PERSONS PARTICIPATING IN A VOLUNTEER SERVICES PROGRAM OF A DEPARTMENT OF THE COUNTY OF HERKIMER AND RATIFYING EXPENSES PREVIOUSLY PAID TO VOLUNTEERS

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. A volunteer shall be defined as a person, other than an officer or employee of the County of Herkimer, who, under the direction of a properly authorized officer of the County of Herkimer, participates in the volunteer services program of a department of the County of Herkimer.

Section 2. Each department head whose department sponsors a volunteer services program shall maintain a roster in department files of all volunteers participating in the department program. Up-to-date copies of such roster shall be periodically filed with the County Auditor and the County Treasurer.

Section 3. Actual and necessary expenses of volunteers incurred during and incident to their participation in such volunteer services program shall be paid as if such volunteers were included in the provisions of Section 203 of the County Law.

Section 4. Payment of expenses previously made by the County of Herkimer to volunteers participating in the program of any County department are hereby ratified and confirmed.

Section 5. This Local Law shall take effect immediately.

LOCAL LAW INTRODUCTORY NO. 1 - 1983 LOCAL LAW NO. 2 - 1983

A LOCAL LAW INCREASING THE SALARIES OF SOME COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED By the Legislature of the County of Herkimer as follows:

- Section 1. The base annual salary of the County Administrator shall be the sum of Twenty Nine Thousand, Nine Hundred Twenty-Five Dollars (\$29,925).
- Section 2. The base annual salary of the County Clerk shall be the sum of Nineteen Thousand, One Hundred Ninety-Three Dollars (\$19,193).
- Section 3. The base annual salary of the County Treasurer shall be the sum of Nineteen Thousand, One Hundred Ninety-Three Dollars (\$19,193).
- Section 4. The base annual salary of the Director of the Real Property Tax Service Agency shall be the sum of Twenty One Thousand, Five Hundred Twenty-Five Dollars (\$21,525).
- Section 5. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of Seventeen Thousand, Eight Hundred Fifty Dollars (\$17,850).
- Section 6. The base annual salary of the County Attorney shall be the sum of Nineteen Thousand, Nine Hundred Fifty Dollars (\$19,950).
- Section 7. The base annual salary of the Commissioners of Elections shall be the sum of Nine Thousand, Five Hundred Eighteen Dollars (\$9,518).
- Section 8. The base annual salary of the Manager of Data Processing shall be the sum of Twenty Two Thousand, Fifty Dollars (\$22,050).
- Section 9. The base annual salary of the Director of the Office for the Aging shall be the sum of Sixteen Thousand, One Hundred Ninety-Six Dollars (\$16,196).
- Section 10. The base annual salary of the Commissioner of Social Services shall be the sum of Twenty Nine Thousand, Two Hundred Twenty-Seven Dollars (\$29,227).
- Section 11. The base annual salary of the Superintendent of Highways shall be the sum of Thirty Five Thousand, One Hundred Seventy-Five Dollars (\$35,175).
- Section 12. The base annual salary of the Director of Veterans' Service Agency shall be the sum of Twelve Thousand, Nine Hundred Seventy-Eight Dollars (\$12,978).
- Section 13. The base annual salary of the Fire Coordinator shall be the sum of Three Thousand, Eight Hundred Thirty-Three Dollars (\$3,833).
- Section 14. The base annual salary of the Commissioner of Lands shall be the sum of Four Thousand, Two Hundred Dollars (\$4,200).
- Section 15. The amounts set opposite the office in each of the foregoing sections includes an increase upon base annual salary of five percent (5%), and the amount of said increase shall be paid to the incumbents of the aforesaid county offices over the last ten pay periods for the year 1983.
- Section 16. The Salary Schedule for the year 1983 shall include for each of the aforesaid officers the said increase of five percent (5%) on base annual salary, and the annual increments and longevity increments as they apply to each officer listed in Sections 1 through 14.
- Section 17. The rate of compensation of the County Coroners shall be the sum of Fifty Dollars (\$50) per call.
 - Section 18. This Local shall take effect forty-five days after its adoption.

LOCAL LAW INTRODUCTORY NO.3 - 1983 LOCAL LAW NO.3 - 1983

A LOCAL LAW INCREASING THE SALARY OF THE DIRECTOR OF THE OFFICE FOR THE AGING DURING HIS TERM OF OFFICE

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. The annual salary of the Director of the Office for the Aging shall be increased so as to include increment and longevity steps for years of service in the amounts provided in the 1983 Salary Schedule of the County of Herkimer.

Section 2. This Local Law shall take effect forty-five days after its adoption.

LOCAL LAW INTRODUCTORY NO. 4 - 1983 LOCAL LAW NO. 4 - 1983

A LOCAL LAW ESTABLISHING PROCEDURE FOR REVIEWING DECISIONS OF ASSESSORS OR DESIGNATED INDIVIDUALS REQUIRING PAYMENT OF INDEMNIFICATION FOR DAMAGES DONE BY DOGS

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. The Legislature of the County of Herkimer, pursuant to Section 125 of the Agriculture and Markets Law, hereby establishes a procedure for reviewing the decision of the assessor or designated individual in instances where a report has been filed by an assessor or designated individual of a town or city requiring the payment of indemnification for damages caused by a dog or dogs in the manner described in said section, and a request for review has been filed.

Section 2. The Committee on Agriculture of the Herkimer County Legislature is hereby designated as the body for reviewing decisions by assessors or designated individuals of towns or cities filed pursuant to Section 125 of the Agriculture and Markets Law.

Section 3. Upon receipt of a request for review the Committee on Agriculture shall make an investigation, or cause an investigation to be made by a designated representative, of the alleged attack upon the claimant's domestic animal. The purpose of such investigation will be to determine the facts surrounding such attack and the amount of the damages incurred thereby for which indemnification should be made. The claimant shall permit the person or persons designated to enter upon the premises on which the attack is alleged to be made and shall furnish whatever information and proof may be available to the claimant and may be deemed necessary by the Committee on Agriculture or its representative to complete the investigation.

Section 4. Upon completion of the investigation the Committee shall determine whether the attack was in fact made by a dog upon a domestic animal and whether the owner had taken reasonable precautions to prevent the damage done; and if the Committee so finds, shall either confirm or deny the determination of the assessor or designated individual or modify it as it may appear proper and adequate in view of the facts. The decision of the Committee shall be in writing and copies thereof shall be mailed to the County Treasurer and the claimant.

Section 5. The County Treasurer shall mail to the claimant a certificate of indemnity due to the claimant and shall retain a copy of the certificate and mail a copy of same to the Commissioner of Agriculture and Markets.

Section 6. This Local Law shall take effect immediately.

LOCAL LAW INTRODUCTORY NO. 6 - 1983 LOCAL LAW NO. 5 - 1983

A LOCAL LAW WAIVING COUNTY RESPONSIBILITY FOR THE ADMINISTRATION AND ENFORCEMENT OF THE NEW YORK STATE UNIFORM FIRE PREVENTION AND BUILDING CODE

BE IT ENACTED by the County Legislature of the County of Herkimer, New York, as follows:

Section 1. The Legislature of the County of Herkimer, New York, hereby waives its responsibility for the administration and enforcement of the Uniform Fire Prevention and Building Code which is to become effective January 1, 1984, and hereby determines that said law will not be enforced by the County of Herkimer. This local law is adopted in accordance with the provisions of Section 381, Paragraph 2 of the Executive Law.

Section 2. The County Clerk of the County of Herkimer is hereby instructed to file a certified copy of this local law in the principal office of the State Building Code Council, Division of Housing and Community Renewal, at Two World Trade Center, New York, New York 10047.

Section 3. This local law shall take effect immediately.

LOCAL LAW INTRODUCTORY NO: 5 - 1983 LOCAL LAW NO: 6-1983

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS OR COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

- Section 1. The base annual salary of the County Administrator shall be the sum of Thirty Two Thousand One Hundred Sixty-Nine Dollars (\$32,169).
- Section 2. The base annual salary of the County Clerk shall be the sum of Twenty Thousand Six Hundred Thirty-Two Dollars (\$20,632).
- Section 3. The base annual salary of the Director of the Real Property Tax Service Agency shall be the sum of Twenty Three Thousand One Hundred Thirty-Nine Dollars (\$23,139).
- Section 4. The base annual salary of the Commissioners of Elections shall be the sum of Ten Thousand Two Hundred Thirty-Two Dollars (\$10,232).
- Section 5. The base annual salary of the Civil Service Commissioners shall be the sum of One Thousand Seven Hundred Fifty Dollars (\$1,750).
- Section 6. The base annual salary of the Commissioner of Social Services shall be the sum of Thirty One Thousand Four Hundred Nineteen Dollars (\$31,419).
- Section 7. The base annual salary of the Manager of Data Processing shall be the sum of Twenty Three Thousand Seven Hundred Four Dollars (\$23,704).
- Section 8. The base annual salary of the Director of the Office for the Aging shall be the sum of Seventeen Thousand Four Hundred Eleven Dollars (\$17,411).
- Section 9. The base annual salary of the Superintendent of Highways shall be the sum of Thirty Seven Thousand Eight Hundred Thirteen Dollars (\$37,813).
- Section 10. The base annual salary of the Fire Coordinator shall be the sum of Four Thousand One Hundred Twenty Dollars (\$4, 120).
- Section 11. The Salary Schedule for the year 1984 shall include the annual increments and longevity increments as they apply to each officer and employee listed in Sections 1 through 10 and shall take effect January 1, 1984.
 - Section 12. This Local Law shall take effect forty-five days after its adoption.
