A LOCAL LAW IN RELATION TO THE ALTERNATIVE VETERANS' EXEMPTION FROM REAL PROPERTY TAXATION

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. The purpose of this Law is to provide that no exemption from real property taxes shall be granted pursuant to Section 458-a of the Real Property Tax Law of the State of New York.

Section 2. Pursuant to the provisions of Subdivision 4 of Section 458-a of the Real Property Tax Law of the State of New York, no exemption from real property taxes shall be granted pursuant to Section 458-a of the Real Property Tax Law for purposes of real property taxes levied for the County of Herkimer.

Section 3. This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York.

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS OR COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. The base annual salary of the County Administrator shall be the sum of Thirty Four Thousand Four Hundred Twenty One Dollars (\$34,421).

Section 2. The base annual salary of the County Clerk shall be the sum of Twenty Two Thousand Seventy Six Dollars (\$22,076).

Section 3. The base annual salary of the County Treasurer shall be the sum of Twenty Two Thousand Seventy Six Dollars (\$22,076).

Section 4. The base annual salary of the District Attorney shall be the sum of Twenty Two Thousand Four Hundred Ninety One Dollars (\$22,491).

Section 5. The base annual salary of the County Auditor shall be the sum of Seventeen Thousand Seven Hundred Fourteen Dollars (\$17,714).

Section 6. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of Twenty Thousand Five Hundred Thirty Two Dollars (\$20,532).

Section 7. The base annual salary of the Director of Real Property Tax Service Agency shall be the sum of Twenty Four Thousand Seven Hundred Fifty Nine Dollars (\$24,759).

Section 8. The base annual salary of the County Attorney shall be the sum of Twenty Two Thousand Nine Hundred Forty Seven Dollars (\$22,947).

Section 9. The base annual salary of the Commissioners of the Board of Elections shall be the sum of Ten Thousand Nine Hundred Forty Eight Dollars (\$10,948).

Section 10. The base annual salary of the Manager of Data Processing shall be the sum of Twenty Five Thousand Three Hundred Sixty Three Dollars (\$25,363).

Section 11. The base annual salary of the Commissioner of Social Services shall be the sum of Thirty Three Thousand Six Hundred Eighteen Dollars (\$33,618).

Section 12. The base annual salary of the Director of Veterans' Service Agency shall be the sum of Fourteen Thousand Nine Hundred Twenty Eight Dollars (\$14,928).

Section 13. The base annual salary of the Director of the Office for the Aging shall be the sum of Eighteen Thousand Six Hundred Thirty Dollars (\$18,630).

Section 14. The Salary Schedule for the year 1985 shall include the annual increments and longevity increments as they apply to each officer and employee listed in Sections 1 through 13 and shall take effect January 1, 1985.

Section 15. This Local Law shall take effect forty-five days after its adoption.

A LOCAL LAW AMENDING LOCAL LAW NO. 1 FOR THE YEAR 1971, AS LAST AMENDED BY LOCAL LAW NO. 2 OF 1982, INCREASING THE ALLOWABLE INCOME FOR REAL PROPERTY OWNERS TO QUALIFY FOR AN EXEMPTION FOR ANYONE WHO IS 65 YEARS OF AGE OR OVER

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. Local Law No. 1 for the year 1971, as last amended by Local Law No. 2 for the year 1982, entitled, "A Local Law to Provide for the Exemption from Taxation by the County of Herkimer to the Extent of Fifty Percentum of the Assessed Valuation of Real Property Owned by One or More Persons 65 Years of Age or Over, or Real Property Owned by Husband and Wife, one of Whom is 65 Years of Age or Over," is hereby amended to read as follows:

Section 3. No exemption, as described in Section 1 hereof, shall be granted in the event that the income of the owner or the combined income of the owners of the property for the tax year immediately preceding the date of making application for exemption exceeds the sum of \$8,000.

Section 2. This Local Law shall take effect forty-five days after its adoption.

A LOCAL LAW ELECTING A RETIREMENT INCENTIVE PROGRAM AS AUTHORIZED BY CHAPTER 665, LAWS OF 1984, FOR THE ELIGIBLE EMPLOYEES OF THE COUNTY OF HERKIMER, NEW YORK

BE IT ENACTED by the Legislature of the County of Herkimer, New York, as follows:

Section 1. The County of Herkimer hereby elects to provide all its eligible employees with a Retirement Incentive Program authorized by Chapter 665, Laws of 1984.

Section 2. The commencement date of the Retirement Incentive Program shall be May 1, 1986.

Section 3. The open period, during which eligible employees may retire and receive the additional retirement benefit, shall be sixty-one (61) days in length.

Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a five year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State Employees' Retirement System, and it shall be paid by the County of Herkimer for each employee who receives the retirement benefits payable under this Local Law.

Section 5. This Local Law shall take effect immediately.

A LOCAL LAW AMENDING LOCAL LAW NO. 4 FOR THE YEAR 1985 ELECTING A RETIREMENT INCENTIVE PROGRAM AS AUTHORIZED BY CHAPTER 665 OF THE LAWS OF 1984 FOR THE ELIGIBLE EMPLOYEES OF THE COUNTY OF HERKIMER, NEW YORK

BE IT ENACTED by the Legislature of the County of Herkimer, New York, as follows:

Section 1. The County of Herkimer hereby elects to provide all its eligible employees with a Retirement Incentive Program authorized by Chapter 665 of the Laws of 1984.

Section 2. The commencement date of the Retirement Incentive Program shall be May 1, 1986.

Section 3. The open period, during which eligible employees may retire and receive additional retirement benefit, shall be [~~sixty-one(61)~~] ninety (90) days in length.

Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a five year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State Employees' Retirement System, and it shall be paid by the County of Herkimer for each employee who receives the retirement benefits payable under this Local Law.

Section 5. This Local Law shall take effect immediately.
