LOCAL LAW NO. 1 - 1997

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS AND COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Herkimer County Legislature of the County of Herkimer as follows:

Section 1. The base annual salary of the County Administrator shall be the sum of Forty Six Thousand, Nine Hundred Nine Dollars (46,909).

Section 2. The base annual salary of the Real Property Tax Director shall be the sum of Thirty Four Thousand and Fourteen Dollars (\$34,014).

Section 3. The base annual salary of the County Treasurer shall be the sum of Thirty Six Thousand, Six Hundred Fifty-Three Dollars (\$36,653).

Section 4. The base annual salary of the Commissioner of Social Services shall be the sum of Forty Nine Thousand, Tow Hundred Fifty-Nine Dollars (\$49,259).

Section 5. The base annual salary of the County Highway Superintendent shall be the sum of Fifty Three Thousand, Four Hundred Forty-Five Dollars (\$53,445).

Section 6. The base annual salary of the County Sheriff shall be the sum of Forty Two Thousand, Two Hundred Twenty- 12 uncounter Dollars (\$42,224).

Section 7. The base annual salary of the Personnel Officer shall be the sum of Thirty Six Thousand, One Hudnred Sixty-Two Dollars (\$36,162).

Section 8. The base annual salary of the County Auditor shall be the sum of Thirty Thousand, Three Hundred Eighty-Two (\$30,382).

Section 9. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of Thirty Five, One Hundred Eighty-Six Dollars (\$35,186).

Section 10. The base annual salary of the County Attorney shall be the sum of Forty Two Thousand Dollars (\$42,000).

Section 11. The salary of the county coroners shall be seventy-five dollars (\$75.00) per call.

Section 12. This Local Law shall take effective forty-five days after its adoption. $\,$

A LOCAL LAW AMENDING LOCAL LAW NO. 4 OF 1995, WHICH ENUMERATES RULES AND REGULATIONS FOR THE ADMINISTRATION OF THE HERKIMER COUNTY SELF-INSURANCE PLAN, BY FURTHER DEFINING ELIGIBLE PARTICIPANTS AND BY CORRECTING PROVISIONS THEREOF

 $\,\,$ BE IT ENACTED by the Legislature of the County of Herkimer, New York as follows:

Section 1. Local Law No. 4 for the year 1995, entitled, "A Local Law Enumerating Rules and Regulations for the Administration of the Herkimer County Self-Insurance Plan" is amended to read as follows:

A. PARTICIPATION

In addition to the County, participation in the Herkimer County Self-Insurance Plan shall be available to the City of Little Falls, and the towns and villages located within the geographic boundaries of Herkimer County and the "the Dolgeville Housing Authority, a public benefit corporation located in the Village of Dolgeville, New York."

Section ${\tt C}$ - Apportionment of Cost, Sub-paragraph 2 is amended as follows:

To participants not electing to cover paid police and firemen, the total of the several amounts set forth in the annual estimate prepared pursuant to Section 67 of the Workers' Compensation Law shall be apportioned to such participants in the proportion that 50 percent of the full vaulation of its taxable real property bears to the aggregate full valuation of all participants, "except that as to the Dolgeville Housing Authority, said estimate shall be apportioned to such participant in the proportion that 10 percent of the full valuation of the taxable real property of the Village of Dolgeville bears to the aggregate full valuation of all participants.

Section 2. Section M - REPEAL OF LOCAL LAWS of said Local Law 3 of 1995 is amended to read as follows:

(1) Upon effective date of this Local Law, all of Local Law 3 of 1956 with the exception of Section 1 and Section 2 thereof, is repealed and superseded, and all of the below listed Local Laws are repealed and superseded:

Local Law 4 of 1956 Local Law 1 of 1967 Local Law 2 of 1976 Local Law 2 of 1978 Local Law 3 of 1981 Local Law 1 of 1984 Local Law 4 of 1993 Local Law 2 of 1993

Section 3. This Local Law shall take effect immediately.
