#### LOCAL LAW NO. 1 - 2001

## A LOCAL LAW INCREASING THE SALARLES OF SOME ELECTED COUNTY OFFICERS AND COUNTY OFFICERS APPOINTED FOR A FIXED DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Herkimer County Legislature of the County of Berkimer as follows:

Section 1. The snaual salary of the County Sheriff shall be the sum of Forty-Seven Thousand Sixty-Four Dollars (\$47,064).

Section 2. The annual salary of the County Treasurer shall be the sum of Forty Thousand Eight Hundred Fifty-Three Dollars (\$40,853).

Section 3. The annual salary of the County Administrator shall be the sum of Fifty Eight Thousand Nine Hundred Thirty-Nine Dollars (\$58,939).

Section 4. The base annual salary of the Commissioner of Social Services shall be the sum of Fifty Four Thusand Nine Hundred Five Dollars (\$54,905).

Section 5. The base annual salary of the County Highway Superintendent shall be the sum of Sixty Four Thousand Five Rundred Seventy-One Dollars (\$64,571).

Section 6. The base annual sasiny of the County Attorney shall be the sum of Pifty Thousand Five Hundred Twenty-Seven Dollars (\$50,527).

Section 7. The base annual salary of the Budget Officer shall be the sum of Forty One Thousand Three Hundred Ninety-Five Dollars (\$41,395).

Section 8. The base annual salary of the County Auditor shall be the sum of Thirty Five Thousand Nine Hundred Tweety-Six Dollars (\$35,926).

Section 9. The base across salary of the Personnel Officer shall be the sum of Forty Seven Thounsad One Hundred Nienty-One Dollars (47,191).

Section 10. The base annual salary of the Real Property Tax Director shall be the sum of Thirty Seven Thousand Nine Hundred Thirteen Dollars (\$37,913).

Section 11. The salary of the county coroners shall be ninety three dollars (\$93.00) per call.

Section 12. This Local Law chall take effect January 1, 2001.

### LOCAL LAW NO. 2 - 2001

A LOCAL LAW FURTHER AMENDING LOCAL LAW NO. 4 FOR THE YEAR 1956, INCREASING THE AMOUNT OF RESERVE UNDER THE HERKIMER COUNTY SELF-INSURANCE PLAN

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. Local Law No. 4 for the year 1956, entitled, "A Local Law Enumerating Rules and Regulations for the Administration of the Herkimer County Self-Insurance Plan", last amended by Local Law No. 2 for 1994 is further amended to read as follows:

### E. RESERVE

- 1). A reserve of \$600,000 is hereby established for the plan. Such amount shall be accumulated by including in each annual estimate a sum not to exceed \$60,000. When the amount of the reserve is the maximum amount, any amount expended therefrom shall be restored by including in subsequent annual estimates a sum not to erceed \$60,000.
- 2). When, in the opinion of the Administrator of said plan, a larger amount is necessary in any one year to maintain the reserve, the Administrator may apply to the Herkimer County Legislature for a payment in any one year greater than \$60,000, but in no event greater than \$100,000.

 $^{\circ}$  Section 2. This Local Law shall take effect forty-five days after its adoption.

# A LOCAL LAW CONTRIBUTING \$25,000 TO THE VILLAGE OF HERKIMER PROJECT TO IMPROVE AND REPAIR RESERVOIR ROAD

The Herkimer County Legislature does enact as follows:


Section 1. The County of Herkimer hereby authorizes the contribution of \$25,000 to a Village of Herkimer project to improve and repair Reservoir Road, in the Village of Herkimer, said project to include realignment of the roadway, drainage, subbase paving and finish paving.

Section 2. The Village of Herkimer has an existing project to improve Reservoir Road from Station 0 + 00, intersection of Lou Ambers Boulevard and Reservoir Road, to Station 16 + 00 - Herkimer County Community College Maintenance Building Entrance, as shown on the attached map. The commitment of these funds will allow an extension of the project to a portion of said roadway from Station 16 + 00 to Station 38 + 00 adjacent to the Rerkimer County Community College soccer fields and said funds are to be expended only for such extension.

Section 3. The contribution of these funds is contingent upon a contribution of \$25,000 by the Town of Herkimer to the Village of Herkimer for the same section of roadway to which the County of Herkimer hereby commits to contribute the above authorized funds.

Section 4. This Local Law shall take effect immediately.

### INTRODUCTORY LOCAL LAW NO. 2 of 2001

LOCAL LAW NO. 4 of 2001

A LOCAL LAW ADOPTING THE PROVISIONS OF REAL PROPERTY TAX LAW SECTION 458-a AS AMENDED IN RELATION TO THE ALTERNATIVE GOLD STAR PARENTS EXEMPTION

BE IT ENACTED, by the Herkimer County Legislature, of the County of Herkimer as follows:

Section 1. That the provisions of New York State Real Property Tax Law Section 458-a, Subdivision 7, of the Real Property Tax Law creating alternative Gold Star Parents real property tax exemptions.

Section 2. That the County of Herkimer hereby adopts and provides that Gold Star Parents shall be included within the definition of "Qualified Owner", as provided in Paragraph C of Subdivision one of Section 458-a of the Real Property Tax Law.

Section 3. That the property owned by a Gold Star Parent shall be included within the definition of "Qualifying Residential Real Property" as provided in Paragraph D of Subdivision 1 of Section 458-a of the Real Property Tax Law, provided that such property shall be the primary residence of the Gold Star Parent.

Section 4. That the additional exemption provided for in Paragraph C of Subdivision 2 of Section 458-a of the Real Property Tax Law shall not apply to real property owned by a Gold Star Parent.

Section 5. This act shall take effect immediately and shall apply to assessment rolls prepared on the basis of taxable status dates occurring on or after the first day of January 2002.
