LOCAL LAW NO. 1 - 2003

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS AND COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Herkimer County Legislature of the County of Herkimer as follows:

- Section 1. The annual salary of the County Sheriff shall be the sum of Forty Eight Thousand Nine Hundred Forty-Seven Dollars (\$48,947).
- Section 2. The annual salary of the County Treasurer shall be the sum of Forty Four Thousand Four Hundred Eighty-Seven Dollars (\$44,487).
- Section 3. The annual salary of the County Clerk shall be the sum of Forty Four Thousand Three Hundred Seventy Three Dollars (\$44,373).
- Section 4. The base annual salary of the County Administrator shall be the sum of Sixty Six Thousand Two Hundred Ninety-Seven Dollars (\$66, 297).
- Section 5. The base annual salary of the Commissioner of Social Services shall be the sum of Fifty Seven Thousand One Hundred One Dollars (\$57,101).
- Section 6. The base annual salary of the County Highway Superintendent shall be the sum of Seventy Two Thousand One Hundred Fifty Four Dollars (\$72,154).
- Section 7. The base annual salary of the County Attorney shall be the sum of Fifty Two Thousand Five Hundred Forty- Eight Dollars (\$52,548).
- Section 8. The base annual salary of the Budget Officer shall be the sum of Forty Three Thousand Fifty-One Dollars (\$43,051).
- Section 9. The base annual salary of the County Auditor shall be the sum of Thirty Seven Thousand Three Hundred Sixty-Three Dollars (\$37,363).
- Section 10. The base annual salary of the Personnel Officer shall be the sum of Forty Nine Thousand Seventy- Nine Dollars (\$49,079).
- Section 11. The base annual salary of the Real Property Tax Director shall be the sum of Thirty Nine Thousand Four Hundred Thirty Dollars (\$39,430).
- Section 12. The base annual salary of the Commissioners of Election shall be the sum of Twenty Nine Thousand Dollars (\$29,000).
- Section 13. The salary of the county coroners shall be ninety seven dollars (\$97.00) per call.
 - Section 14. This Local Law shall take effect forty-five days after its adoption

LOCAL LAW NO. 2 - 2003

A LOCAL LAW REGARDING REVISION OF THE BOUNDARIES OF THE ONEIDA-HERKIMER EMPIRE ZONE

WHEREAS, New York State has created the Economic Development Zone Program to encourage industrial and commercial development in selected municipalities across the State; and

WHEREAS, Oneida County, as an eligible municipality, received designation of an Economic Development Zone on June 3, 1998 made upt of sub-zones including portions of the Town and Village of Frankfort, Village of Ilion, Town of Whitestown, Town of New Hartford, City of Rome; and

WHEREAS, Oneida County and Herkimer County subsequently revised and amended the original Economic Development sub-zone boundaries (now referred to as Empire Zones) on August 22, 2002; and

. WHEREAS, Oneida County intends to revise the Empire Zone's boundaries to encourage industrial and commercial development and allow for the creation of an additional subzone in the County of Herkimer; and

WHEREAS, THE County of Herkimer wishes to support and concur with the Empire Zone revision application; now, therefore

BE IT ENACTED, by the County Legislature of the County of Herkimer as follows:

Section 1. That the Herkimer County Legislature, in its capacity as governing body of the County, does hereby support and concur with the Oneida Herkimer Counties Empire Zone revision application.

Section 2. This local law shall take effect immediately.

LOCAL LAW NO. 3 - 2003

A LOCAL LAW AUTHORIZING THE COUNTY TO SELL REAL PROPERTY BY PRIVATE SALE

Section 1. Pursuant to the Muncipal Home Rule Law and the Charter of the County of Herkimer, duly adopted on August 17, 1966, the County Legislature of the County of Herkimer shall have the power to sell any county owned real property which is no longer necessary for public use by private sale.

Section 2. The County of Herkimer shall also retain the right to sell real property at public sale, as provided in the appropriate statutes, and the right to sell such property at private sale shall be in addition, and a supplement to the right to sell at public sale.

Section 3. This local law shall take effect forty-five days after its adoption.
