## LOCAL LAW NO. 1 - 1971

## COUNTY OF HERKIMER, NEW YORK

A LOCAL LAW TO PROVIDE FOR THE EXEMPTION FROM TAXATION BY THE COUNTY OF HERKIMER TO THE EXTENT OF FIFTY PER CENTUM OF THE ASSESSED VALUATION OF REAL PROPERTY OWNED BY ONE OR MORE PERSONS, EACH OF WHOM IS 65 YEARS OF AGE OR OVER, OR REAL PROPERTY OWNED BY HUSBAND AND WIFE, ONE OF WHOM IS 65 YEARS OF AGE OR OVER.

BE IT ENACTED by the Legislature of the County of Herkimer, New York, as follows:

Section 1. That real property owned by one or more persons, each of whom is 65 years of age or over, or real property owned by husband and wife, one of whom is 65 years of age or over, shall be exempted from taxation by the County of Herkimer to the extent of 50 per centum of the assessed valuation thereof.

Section 2. No exemption, as described in Section 1 hereof, shall be granted by the County of Herkimer unless there is a compliance with the provisions of Section 467 of the Real Property Tax Law of the State of New York.

Section 3. No exemption, as described in Section 1 hereof, shall be granted in the event that the income of the owner, or the combined income of the owners of the property, for the tax year immediately preceding the date of making application for exemption exceeds the sum of \$3,000.

Section 4. This Local Law shall take effect January 1, 1973.

## LOCAL LAW NO. 2 - 1971

## COUNTY OF HERKIMER, NEW YORK

A LOCAL LAW INCREASING THE SALARIES OF SOME COUNTY OFFICERS, APPOINTED FOR A FIXED TERM, DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

- Section 1. The annual salary of the County Superintendent of Highways and Engineer shall be the sum of Eighteen Thousand Nine Hundred Ninety Dollars (\$18,990).
- Section 2. The annual salary of the Commissioners of Elections shall be the sum of Four Thousand Five Hundred Forty Dollars (\$4,540).
- Section 3. The annual base salary of the Commissioner of Jurors shall be the sum of Two Thousand Eight Hundred Twenty Dollars (\$2,820), and he shall receive increments as established in the salary schedule.
- Section 4. The annual salary of the Commissioner of Social Services shall be the sum of Eleven Thousand Six Hundred Five Dollars (\$11,605).
  - Section 5. This Local Law shall take effect forty-five (45) days after its adoption.
