WHEREAS, pursuant to Resolution No. 177 of 2009 an Investment Policy of the County of Herkimer was adopted, which Resolution was amended by Resolution No. 136 of 2011; and

WHEREAS, by Resolution No. 163 adopted on July 6, 2016 said revised Herkimer County Investment Policy was further amended; and

WHEREAS, by letter dated September 20, 2016, Kimberlee A. Enea, Herkimer County Treasurer, has requested said Investment Policy be further amended to include additional language in the Collateralizing of Deposits section of the Policy; now, therefore, be it

RESOLVED, that Resolution No. 177 of 2009 adopting an Investment Policy of the County of Herkimer, as amended by Resolution No. 136 of 2011 and by Resolution No. 163 of 2016, is hereby further amended on page 2 under the heading "Collateralizing of Deposits, to add an additional No. 2 to read as follows:

"2. By a letter of credit payable to the County of Herkimer as security for the payment of one hundred percent of the aggregate amount of deposits, as provided by General Municipal Law, Section 10."

And, be it further

RESOLVED, that in all other respects Resolution No. 177 of 2009 adopting an Investment Policy of the County of Herkimer, as attached and as amended by Resolution No. 136 of 2011 and Resolution No. 163 of 2016, is hereby ratified and confirmed; and, be it further

RESOLVED, that certified copies of this Resolution be forwarded to the Herkimer County Treasurer, Auditor, Budget Officer and County Attorney.

INVESTMENT POLICY FOR HERKIMER COUNTY

This investment policy applies to all moneys and other financial resources available for investment on its own behalf of any other entity or individual.

OBJECTIVES

The primary objectives of the County's investment activities are, in priority order,

- > to conform with all applicable federal, state, and other legal requirements;
- > to adequately safeguard principal;
- > to provide sufficient liquidity to meet all operating requirements;
- > to obtain a reasonable rate of return

DELEGATION OF AUTHORITY

The governing board's responsibility for administration of the investment program is delegated to the treasurer who shall establish written procedures for the operation of the investment program control structure to provide a satisfactory level of accountability based on a data base or records incorporating description and amounts of investments, transaction dates, and other relevant information and regulate the activities of subordinate employees.

PRUDENCE

All participants in the investment process shall seek to act responsibly as custodians of the public trust and shall avoid any transaction that might impair public confidence in the County to govern effectively.

Investments shall be made with judgment and care, under circumstances than prevailing, which persons of prudence discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

All participants involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

DIVERSIFICATION

It is the policy of the County to diversify its deposits and investments by financial institution, by investment instrument, and by maturity scheduling.

INTERNAL CONTROLS

It is the policy of the County for all money collected by any officer or employee of the government to transfer those funds to the Treasurer within 30 days of deposit, or within the time period specified in Law, whichever is shorter.

The Treasurer is responsible for establishing and maintaining an internal control structure to provide reasonable, but not absolute, assurance that deposits and investments are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization and recorded properly, and are managed in compliance with applicable law and regulations.

DESIGNATION OF DEPOSITORIES

"The banks and trust companies authorized for the deposit of moneys shall be listed and in the amounts indicated on the resolution adopted annually for the Depositories of County Funds."

COLLATERALIZING OF DEPOSITS

In accordance with the provisions of General Municipal Law, Section 10, all deposits of Herkimer County, including certificates of deposit and special time deposits, in excess of the amount insured under the provisions of the Federal Deposit Insurance Act shall be secured:

- 1. By a pledge of "eligible securities" with an aggregate "market value", as provided by General Municipal Law, Section 10, equal to the aggregate amount of deposits.
- 2. By a letter of credit payable to the County of Herkimer as security for the payment of one hundred percent of the aggregate amount of deposits, as provided by General Municipal Law, Section 10.

SAFEKEEPING AND COLLATERALIZATION

Eligible securities used for collateralizing deposits shall be held by a third party bank or trust company subject to security and custodial agreements.

The security agreement shall provide that eligible securities are being pledged to secure local government deposits together with agreed upon interest, if any, and any costs or expenses arising out of the collection of such deposits upon default. It shall also provide the conditions under which the securities may be sold, presented for payment, substituted or released and the events which will enable the local government to exercise its rights against the pledged securities. In the event that the securities are not registered or inscribed in the name of the local government, such securities shall be delivered in a form suitable for transfer or with an assignment in blank to the County or its Custodial bank.

The custodial agreement shall provide that securities held by the bank or trust company, or agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement should also describe that the custodian shall confirm the receipt, substitution or release of the securities. The agreement shall provide for the frequency of revaluation of eligible securities and for the substitution of securities when a change in the rating of a security may cause ineligibility. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

PERMITTED INVESTMENTS

As authorized by General Municipal Law, Section 11, the County of Herkimer authorized the Treasurer to invest moneys not required for immediate expenditure for terms not to exceed one year in the following types of investments:

- Special time deposit including certificate of deposit issued by a bank or trust company authorized to do business in the State;
- Certificates of deposit;
- ➤ Obligations of the United States of America
- Dbligations guaranteed by agencies of the United States of America where the payment of principal and interest are guaranteed by the United State of America;
- Obligations of the State of New York;

All investment obligations shall be payable or redeemable at the option of the County of Herkimer within such times as the proceeds will be needed to meet expenditures for purposes for which the moneys were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the County of Herkimer within one year of the date of purchase.

AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS

The County of Herkimer shall maintain a list of financial institutions and dealers approved for investment purposes and establish appropriate limits to the amount of investments which can be made with each financial institution or dealer. All financial institutions with which the local government conducts business must be credit worthy. Banks shall provide their most recent Consolidated Report of Condition at the request of the County of Herkimer. Security dealers not affiliated with a bank shall be required to be classified as reporting dealers affiliated with New York Federal Reserve Bank, as primary dealers. The Treasurer is responsible for evaluating the financial position and maintaining a listing of proposed depositories, trading partners and custodians. Such listing shall be evaluated at least annually.

PURCHASE OF INVESTMENTS

The treasurer or deputy treasurer is authorized to contract for the purchase of investments:

- 1) A minimum of three bids shall be obtained and recorded.
- 2) All investments shall be in the name of the County.
- 3) The Treasurer's Department will maintain an investment log detailing the specific information relative to each investment. The log will contain descriptions, account numbers, fund, amounts transaction dates, interest rates, maturity, interest earned, date of disposition and other related information.
- 4) Investment transaction shall be reported to the Jr. Accountant to be recorded in the accounting system.
- 5) All Certificates of Deposit or other evidence of investment shall be kept in the safe.
- 6) Terms and Conditions

Minimum 7 days

Maximum 365 days

- 7) All investment documentation shall be retained for audit purpose.
- 8) Investments shall be sufficiently liquid so as to allow funds to be available as needed to meet the obligations of the County.
- 9) Funds shall be invested in such a way as to earn the maximum yield possible.

COUNTY CLERK

In addition to the authority to invest herein given to the County Treasurer, the County Clerk, pursuant to Section 11 (5) of the General Municipal Law may invest any money collected on behalf of the state until such time as the money is required to be remitted to the state. The County Clerk shall invest the state money only in those investments by this policy and payable with such time as the proceeds shall be payable in equal shares to the state and to the County, provided, however, that any fees or service charges associated with the investment shall be paid from such interest.

WHEREAS, this is the first time that Herkimer County has been assessed for these expenses; and

RESOLVED, that the Chairman of this Legislature is hereby authorized to sign and file a complaint with the Hudson River-Black River Regulating District seeking a revision of the Black River area apportionments to remove any assessment levied against the County of Herkimer and other counties.

RESOLUTION CONCERNING THE ESTABLISHMENT OF THE GREATER MOHAWK VALLEY LAND BANK CORPORATION AND APPOINTING REPRESENTATIVES TO SERVE ON GREATER MOHAWK VALLEY LAND BANK BOARD AND RESCINDING RESOLUTION NO. 184 ADOPTED ON JULY 27, 2016

Sponsored by: Committee on County Properties Committee on Ways and Means

WHEREAS, New York State has recognized the need to provide new tools and innovative solutions to address deteriorated, abandoned and tax-delinquent properties and the blight they inflict upon communities; and

WHEREAS, New York State acknowledges the risks to public health and safety caused by seriously derelict properties; and

WHEREAS, land banks allow and provide a mechanism for the re-development, repair, improvement, or in appropriate situations, deconstruction of blighted properties; and

WHEREAS, land banks have now been firmly established nationally, with a success record in helping to ameliorate the above negative impacts; and

WHEREAS, in recognition of same and in order to revitalize and strengthen local communities and economies New York State has adopted a Land Bank Act ("Not-for-Profit" Corporation Law, Article 16); and

WHEREAS, a number of communities in the Greater Mohawk Valley with the direction and encouragement of the Mohawk Valley Economic Development District ("MVEDD"), desire to create a regional land bank in order to efficiently and effectively address blight across the Greater Mohawk Valley; and

WHEREAS, in accordance with the provisions of the Land Bank Act, it is necessary to adopt a resolution establishing the Greater Mohawk Valley Land Bank Corporation ("GMVLB") on behalf of the County of Herkimer and the other signatories, and addressing certain other requirements relating to the structure and function of the GMVLB; therefore it is

RESOLVED, that the County of Herkimer hereby establishes and authorizes the creation of a regional land bank, as follows:

- 1. Name of the land bank: Greater Mohawk Valley Land Bank Corporation;
- 2. Number of initial members of the board of directors: 9
- 3. The initial individuals to serve on the GMVLB board and their initial terms of office are:
 - (a) Appointed by the Chairman of the Legislature and confirmed by the Herkimer County Legislature:
 Raymond Johnson (County Legislator), initial term of 2 years;
 Kurt Ackerman (County Legislator), initial term of 1 year;

- (b) Appointed by the County Executive of Montgomery County: Karl Gustafson (Office of the Executive), initial term of 2 years;
- (c) Appointed by Chair of the Board of Representatives of Otsego County: Margaret M. Kennedy (County Representative), initial term of 2 years; Craig Gelbsman (County Representative), initial term of 1 year;
- (d) Appointed by Chair of the Board of Supervisors, confirmed by Resolution of the Board of Schoharie County:
 Steven Wilson (County Administrator), initial term of 2 years;
- (e) Appointed by the Mayor of the City of Rome:Mark Domenico (Chief Code Enforcement Officer), initial term of 1 year;
- (f) Appointed by the Mayor of the City of Utica: Brian Thomas (Commissioner, Urban & Economic Development); initial term of 2 years;
- (g) Appointed by the Common Council of the City of Utica: Joseph A. Marino (Chair, Economic Development Committee), initial term of 1 year;
- 4. Board members must be a resident of the county or city from which they are appointed. Each of the joining counties and the joining cities will be entitled to have the number of members on the board of directors as listed above. The regular terms of office of members of the board shall be 2 years, in addition to any partial term for which a member is appointed to fill a vacancy.
- 5. The proposed articles of incorporation of the GMVLB are approved for inclusion in the application for the GMVLB which is to be sent to Empire State Development.
- 6. The County of Herkimer (together with the other joining counties and cities) will enter into and the Chairman of the Legislature is authorized to execute an Intermunicipal Agreement for the creation of GMVLB, and is authorized to execute such other documents as may be necessary to establish the GMVLB, subject to the approval of the County Attorney.
- 7. Resolution No. 184 adopted July 27, 2016 is hereby rescinded.

- (b) Appointed by the County Executive of Montgomery County: Karl Gustafson (Office of the Executive), initial term of 2 years;
- (c) Appointed by Chair of the Board of Representatives of Otsego County: Margaret M. Kennedy (County Representative), initial term of 2 years; Craig Gelbsman (County Representative), initial term of 1 year;
- (d) Appointed by Chair of the Board of Supervisors, confirmed by Resolution of the Board of Schoharie County: Steven Wilson (County Administrator), initial term of 2 years;
- (e) Appointed by the Mayor of the City of Rome: Mark Domenico (Chief Code Enforcement Officer), initial term of 1 year;
- (f) Appointed by the Mayor of the City of Utica: Brian Thomas (Commissioner, Urban & Economic Development); initial term of 2 years;
- (g) Appointed by the Common Council of the City of Utica: Joseph A. Marino (Chair, Economic Development Committee), initial term of 1 year;
- 4. Board members must be a resident of the county or city from which they are appointed. Each of the joining counties and the joining cities will be entitled to have the number of members on the board of directors as listed above. The regular terms of office of members of the board shall be 2 years, in addition to any partial term for which a member is appointed to fill a vacancy.
- 5. The proposed articles of incorporation of the GMVLB are approved for inclusion in the application for the GMVLB which is to be sent to Empire State Development.
- 6. The County of Herkimer (together with the other joining counties and cities) will enter into and the Chairman of the Legislature is authorized to execute an Intermunicipal Agreement for the creation of GMVLB, and is authorized to execute such other documents as may be necessary to establish the GMVLB, subject to the approval of the County Attorney.
- 7. Resolution No. 184 adopted July 27, 2016 is hereby rescinded.
