WHEREAS, by letter dated April 15, 2016, JoAnn Boyer, Director of Information Services, has advised that a proposal has been received to provide equipment and installation of a new Countywide Telephone System; and

WHEREAS by letter dated May 13, 2016, Sheri Ferdula, Budget Officer, has advised that it is the recommendation of your Committees that a contract be entered into with Annese & Associates of Herkimer, New York, to provide said services at a cost of \$249,704.26, which is New York State Contract pricing and includes five years of hardware maintenance and software upgrades; and
