REPORT AND RESOLUTION OF THE COMMITTEE ON HUMAN RESOURCES AND WAYS AND MEANS AUTHORIZING BIDS FOR BILLING SERVICE FOR PUBLIC HEALTH

WHEREAS, regulatory changes from the New York State Department of Health have prohibited the administration of childhood vaccinations provided under the Vaccines for Children Program to persons who have commercial insurance; and

WHEREAS, this Legislature is informed by communication dated December 6, 2012 from Bernard E. Decker, Budget Officer/Purchasing Agent, that specifications are being prepared for the provision of a billing service that will allow the Public Health Nursing Service to continue to vaccinate children with commercial insurance; now, therefore, be it
