Wednesday, June 15, 2011
7:30 p.m.

The Regular Session of the Herkimer County Legislature was called to order by Chairman Raymond Smith at 7:30 p. m.

Chairman Smith called on Dairy Princess Jennifer Hula to lead the Legislature in the Pledge of Allegiance.

Pursuant to Rule 8 of the Rules of the County Legislature, Chairman Smith asked if there were any objections or corrections to the minutes of May 18, 2011 and the minutes of the special session held on June 3, 2011. There were no objections and the minutes were approved.

Chairman Smith dispensed with the regular to allow for the presentation of a proclamation. He called upon Legislator Bernard Peplinski who presented a proclamation to Dairy Princess Jennifer Hula and her court, in recognition of June as Dairy Month.

Chairman Smith then called on Bill Rabbia, Executive Director of the Oneida-Herkimer Solid Waste Authority, to make a presentation. Mr. Rabbia explained the “Recycleone. One and Done” Program which begins July 5, 2011 and will allow residents to place all their recyclable items together in one bin for collection. He also added that with single stream recycling they will add #7 to list of allowable plastics for recycling. Several legislators had questions and Mr. Smith thanked Mr. Rabbia for attending the session.

**REPORT AND RESOLUTION OF THE COMMITTEE ON WAYS AND MEANS
AUTHORIZING EXTENSION OF CONTRACT WITH THE TOWN OF SALISBURY
FOR THE COUNTY TO PROVIDE DATA COLLECTION SERVICES**

WHEREAS, by Resolution No. 164 of 2003 this Legislature approved a contract with the Town of Salisbury whereby the County would provide data collection to the Town of Salisbury for a period of one year for the sums as outlined in said Resolution, which resolution was amended and extended for additional one year periods; and

WHEREAS, by letter dated May 16, 2011, Mary Ann Barbuto, Director of the Real Property Tax Service Agency, has requested said contract be extended for an additional one year period; and

WHEREAS, it is the opinion of your Committee that it is to the mutual benefit of the County of Herkimer and the Town of Salisbury for the County of Herkimer to continue to provide said data collection services to the Town; now, therefore, be it

RESOLVED, as follows:

1. The County of Herkimer is authorized to provide data collection services to the Town of Salisbury for the period June 18, 2011 through June 18, 2012 on the number of parcels to be designated by the Town for the sum of \$10.00 per parcel per visit for Agricultural, Residential, Vacant and Public Service parcels; a cost of \$32.00 per parcel per visit for Commercial, Recreation, Community Service, Industrial and Forest and Public Parks parcels. Trailer parks shall be charged as one parcel if the park owner provides the inventory of trailers in the park. In the event that the Data Collector must collect such information, the charge shall be \$3.00 per site. The County shall be further entitled to mileage each year.

2. The Chairman of this Legislature is authorized to enter into an extension and modification of said agreement with the Town of Salisbury for the period from June 18, 2011 to June 18, 2012 with the final form of said contract to be subject to the approval of the County Attorney;

3. Certified copies of this Resolution shall be forwarded to the Herkimer County Treasurer, Auditor, Budget Officer, Director of Real Property Tax Services and the Town of Salisbury.

WHEREAS, by Resolution No. 114 for the year 2011 duly adopted on April 6, 2011, this Legislature authorized and directed the sale at public auction, after due advertisement, of certain county owned tax acquired real property under the direction of the County Treasurer; and

WHEREAS, the Properties Committee of this Legislature reports that said sale was duly held pursuant to said direction on June 4, 2011 at Herkimer, New York; and

WHEREAS, pursuant to the terms of sale the successful bidder on each parcel sold is required to pay the full purchase price together with recording fee and transfer tax by June 24, 2011; and

WHEREAS, the Properties Committee reports that the total number of parcels sold at the auction sale is 64 and the total amount to be received on said sales is \$537,020.00 as shown on the lists made available to each Legislator and filed with the Clerk of the Legislature; and

WHEREAS, the Properties Committee recommends approval of each sale as set forth on the said list, and conveyance of each said parcel to the successful bidder thereon providing

payment in full of the amount bid and required fees was received by the County Treasurer's Office; and

**RESOLUTION OF THE COMMITTEE ON ADMINISTRATION/VETERANS AFFAIRS
TO APPOINT A COMMISSION TO EVALUATE EXISTING COUNTY LEGISLATIVE
DISTRICTS FOR EQUITY AND REPRESENTATION**

WHEREAS, the County of Herkimer adopted a County Charter in 1966, which establishes county legislative districts within the County of Herkimer; and

WHEREAS, the said Charter provides that the County Legislature shall appoint a commission to evaluate existing county legislative districts for equity and representation in relation to population within three months after publication of the results of each federal census; and

WHEREAS, the County Charter provides that said commission shall consist of the Commissioners of the County Board of Elections, the Chairman of the County Legislature, one person selected by the members of the majority political party in the County Legislature, and one person selected by the members of the minority party or parties represented in the County Legislature; now, therefore, be it

RESOLVED, that a commission be appointed to evaluate the existing county legislative districts for equity and representation in relation to population, to consist of the Chairman of the legislature, the Election Commissioners, one member selected by the majority party in the Legislature, said selection to be indicated by a letter filed with the clerk of this Legislature, and one member selected by the minority party in the Legislature, said selection to be indicated by a letter filed with the clerk of the Legislature; and, be it further

RESOLVED, that said Commission shall serve per the duties provided in Section 206 of the Charter of the County Legislature of the County of Herkimer; and, be it further

RESOLVED, that certified copies of this Resolution be forwarded to each member of the Commission with all convenient speed.
