MINUTES

Herkimer County Legislature Fourth Quarter – Second Day Wednesday, October 26, 2011 7:30 p.m.

The Regular Session of the Herkimer County Legislature was called to order by Chairman Raymond Smith at 7:30 p. m.

Chairman Smith called on Mary Ann Barbuto, Director of Real Property Tax Services, to lead the Legislature in the Pledge of Allegiance.
