RESOLUTION OF THE COMMITTEE ON ADMINISTRATION/VETERANS AFFAIRS REGARDING PROPOSED DEC REGULATIONS ON OUTDOOR WOOD BOILERS

WHEREAS, the New York State Department of Environmental Conservation has proposed new regulations on outdoor wood boilers which would impose severe restrictions on the use of outdoor wood boilers, including extensive modifications to existing wood boilers with no regard to whether such modifications are necessary for a particular boiler; and

WHEREAS, the proposed regulations would also require the replacement of existing wood boilers, with some boilers requiring replacement by 2015 and other boilers by 2020; and
