#### Herkimer County Legislature Third Quarter – First Day Wednesday, July 10, 2024 2:00 p.m.

The Regular Session of the Herkimer County Legislature was called to order by Chairman Robert D. Hollum at 2:00 p.m.

WHEREAS, by letter dated June 21, 2024 from Sheri Ferdula, Budget Officer/ Purchasing Agent, this legislature has been notified that the agreement for office space for Indigent Legal Services (ILS) was terminated and they will be vacating the space at the end of July; and

WHEREAS, the office is currently bare space and will need to be renovated, with the build out cost totaling \$78,175, of which \$39,087.50 is the ILS share, to be paid up front for construction to begin, with ARC Herkimer providing a temporary space for the eight week construction; and

WHEREAS, once the office space is complete, the rental fee will be \$12 per square foot including utilities, for 1,500 square feet, totaling \$14,000 annually or \$1,200 per month, for three years; now, therefore, be it
