WHEREAS, by letter dated September 4, 2024, John J. Piseck, Jr., Chief Executive Officer of the Herkimer County Industrial Development Agency has requested that the Herkimer County Legislature consider authorizing a grant in the amount of \$100,000 between Herkimer County and Mohawk Valley EDGE for the remediation of environmental contamination at 4360 Acme Road, Frankfort, New York known as the former "CHIPS" site; and

WHEREAS, as set forth in the above letter, the County will be reimbursed 100% of the cleanup cost and the grant funds will be administered by the Herkimer County Industrial Development Agency [hereafter "IDA"]; and
