#### **INTRODUCTORY LOCAL LAW A - 2025**

#### **LOCAL LAW NO. 2 - 2025**

# A LOCAL LAW REGARDING AMENDMENT OF THE COUNTY CHARTER TO EXTEND THE TERM OF OFFICE FOR ALL COUNTY LEGISLATORS FROM TWO YEARS TO FOUR YEARS

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. The third paragraph of Section 201 of the Charter of the County Legislature of the County of Herkimer, adopted August 11, 1966 and approved at the election held November 8, 1966, is hereby repealed.

Section 2. A new third paragraph of Section 201 is hereby added to said Charter, to read and provide as follows:

Except as provided in this section or as otherwise provided by law, the term of the members of the county legislature shall be for four years, and shall begin on the first day of January next following their election. Said elections for the county legislators shall be conducted at general elections, with the first election of members to such four year terms to be conducted in the general election in the year two thousand twenty six, and every fourth year thereafter at the general election held in such year.

Section 3. This Local Law is subject to mandatory referendum as required by Section 23 of the Municipal Home Rule Law for approval of qualified voters of the County of Herkimer at the general election to be held on November 4, 2025. A proposition in the following form shall be included on the ballot at such general election, and the increased term of office shall not take effect unless such proposition is approved by the majority of the qualified voters voting thereon:

"Shall Introductory Local Law A of 2025 entitled Local Law regarding amendment of the County Charter to extend the term of office for all County Legislators from two years to four years be approved?"
