They accept responsibility for providing the above contribution of the local share to reimburse expenses to Herkimer County.

HOCTS

HOCTS will provide technical, administrative and support staff services for two year period of the grant funding. They will prepare all required reporting, attend required meetings, submit closeout documentation and will assist with any federal regulations required by the FTA. The HOCTS will receive \$10,000 (\$5,000 for 2017 and \$5,000 for 2018) which will be offset by the annual appropriation of FTA Section 5303 funding, provided for their role as the Metropolitan Transportation Planning (MPO) agency for Oneida and Herkimer Counties.
